ACTIVITIES

MEMBERSHIP MODEL

2022 was a massive year in terms of onboarding our members. I had many discussions with the board to try to find a solution for the unique circumstances of each of our clubs. 2022 was an opportunity to work with individual heads of style to understand the operational environment of each club and gain a greater understanding of the challenges faced by different organisations.

The onboarding process was refined over the course of 2022 until we reached a process that covers all circumstances for our members. A large body of work included working with our software supplier, Revolutionise Sport.

This has simplified the signup process for all parties and meets the privacy requirements as per the Karate Australia Privacy Policy.

MEMBERSHIP STATUS

Historically membership of the Federation was only available to Heads of Style of a karate organisation.

All Heads of Style had their organisations recognised as provisional members of the Australian Karate Federation Limited on conversion to a Company Limited by Guarantee. This provisional membership expired after the 1st AGM of the company (6 April 2022) per the constitution of the Company.

The Board of Directors re-instated (grandfathered-in) all former members on 7 April 2022 as provisional members of the Company to assist with the roll out of membership signup by individual members. The constitution of the Company provides that clubs / organisations have 12 months to be compliant with the provisions of organisational membership to be confirmed as members. Member organisations had from 15 December 2021 to 6 April 2023 to onboard their members and be compliant with the provisions of membership.

Karate Australia is happy to report that the AKF has 115 active member clubs eligible to attend this AGM. But even more exciting to report is that as of 7 April 2023 the number of individual members is 12,424 (1,395 - 1 April 2022). The Board had an internal target of 10,000 members in the 1st year and reached this number on 20 February 2023

MEMBERSHIP POLICY

Over the course of the year the Board refined and reviewed the membership policy. The constitutional principles are fit for purpose and are reviewed on an ongoing basis. The principal scope of work in the early part of 2023 has been understanding attempts to circumvent the membership requirements.

The management of the Company understands that it has a duty to the member clubs to ensure that member clubs act in the best interests of Karate, the Company and other members to ensure that all member clubs support the objectives of the company. To this end Policy has been adopted and management remains vigilant in dealing with clubs who assist in attempts to circumvent the membership policy.

Karate Australia will continue to actively promote, encourage, and support clubs to onboard their members in accordance with the Company Policies. This is an ongoing process, with Karate Australia aiming to have year on year growth.

FUNDING

Karate Australia has secured Participation Funding from the Australian Sports Commission for 2023. The Australian Sports Commission is currently working on a new participation funding model which will be released later this year. The Federation will work to maximise the opportunities the new model brings.

DATABASE / WEBSITE

In December 2020, the company signed an agreement with Revolutionise Sport to manage its membership database and website requirements. Revolutionise Sport is the platform of choice for Hockey Australia, Softball Australia, Water Polo Australia, Rowing Australia, Golf Australia and many other National Sporting Organisations (NSO). The process of managing and creating a platform for our membership model has been well supported by Revolutionise Sport and Omni Online have assisted with website development and migration.

A number of clubs, both large and small, are now using Revolutionise Sport to manage their membership and in some cases the complete management of their clubs, including invoicing, classes, gradings, website and a whole host of additional functions. Karate Australia encourages those members wishing to manage their members to discuss options with the National Office.

WORLD KARATE FEDERATION

The Australian Karate Federation is a member in good standing of the World Karate Federation.

The 2022 WKF Congress was marked by a fitting tribute to Con Kassis who passed away 7 June 2022. The WKF President Antonio Espinós invited Con Kassis' wife Rosanna to the stage to join the Karate family in honouring Con. Rosanna gave an emotional and heartfelt tribute and the WKF President Antonio Espinós stressed Con Kassis' invaluable contribution to Karate and his passion for the discipline he truly loved. I am very pleased to have been in attendance to witness the love of the world karate family for Sensei Con Kassis.

OCEANIA KARATE FEDERATION

2022 saw the return of the Oceania Karate Federation Championships after the pandemic. New Caledonia put on a spectacular show. It was a fantastic event with great performances and results. It was good to see our friends from the region back in competition. The last few years have been difficult for the Oceania Karate Federation (OKF), principally because of border restrictions. Congress and Championships had to be postponed twice. Several executive meetings and a significantly larger number of ad-hoc meetings were held online.

Michael Kassis was elected president at a Special General Meeting in December 2021 and at congress on 5 June 2022, Hani Zahra was elected 1st vice president of the Federation.

AUSTRALIAN OLYMPIC COMMITTEE

The Australian Karate Federation is a "recognised sport" within the Australian Olympic Committee. As a recognised sport the Company is invited to attend the AGM of the AOC. Glen Scott is our delegate to congress and attends on behalf of the company.

We have worked closely with the AOC to maximise opportunities for our athletes; recognising that the AOC focusses their resources on Olympic sports and will continue to lobby for support for our athletes.

Karate Australia will be working with the WKF, OKF, ANOC and other parties in supporting activities to have karate included in Brisbane 2032.

NATIONAL INTEGRITY FRAMEWORK

In 2020, the Australian Sports Commission created a new entity called Sport Integrity Australia. Sport Integrity Australia has developed a National Integrity Framework.

The National Integrity Framework is one of the Australian Karate Federation's responses to the threats to the integrity of karate and sets out the broad expectations for the conduct of all participants in karate, including procedures for managing, reporting, investigating, and determining potential breaches of its Integrity policies.

In 2022 Karate Australia adopted the National Integrity Framework. However In October 2022, Sport Integrity Australia surveyed the sport sector on proposed policy revisions to the National Integrity Framework (NIF) as part of a continuous improvement process. Through this process the sector requested another opportunity to provide comment on the updated policy suite in its entirety.

In terms of key changes:

- The Framework is now a suite of five policies consisting of:
 - o Member Protection Policy
 - o Child Safeguarding Policy
 - o Improper Use of Drugs and Medicine Policy
 - o Competition Manipulation and Sports Gambling Policy,
 - o Complaints, Disputes and Discipline Policy (CDDP).

The National Office is currently working through the proposed policies together with various other sports. The policies are also being reviewed in relation to our State Associations.

KARATE INSTRUCTOR ACCREDITATION

Following the 2022 AGM, the new Karate Instructor Accreditation process was launched, whereby AKF member instructors are able to upload certificates for completion of online courses, annual compliance certification and request accreditation.

Karate Australia has taken the view that education of the whole of karate is to the greater benefit of all, and the cost of accreditation has been reduced to a minimum.

As part of the membership model all karate instructors within a club are required to complete Bronze level Karate Instructor Accreditation.

Thank you to Neville Thorley for role as director for this programme.

WKF WORLD CHAMPIONSHIPS - KONYA

In 2022 Australia maintained its 100% attendance at every World Championship, by sending a team to the Cadet Junior / U21 WKF World Championship in Konya, Turkey.

The highlight of this event was the Bronze Medal won by Kento Oiwa, in cadet male kata. This is a fantastic achievement, and the Australian karate community congratulates Kento.

The Board has provided a scholarship for Kento, to recognise his outstanding achievement. This includes National Squad registration, National Team uniform, competition entry fees to the Australian Open and National Championships as well as \$500 funding grant to be used for a selected national team tour.

WORLD BEACH GAMES

The 2023 edition of the World Beach Games is to be held In Bali in August 2023. The Australian Olympic Committee has not accepted our pleadings to be included in their programme for the games. Karate Australia is disappointed with the decision by the AOC who have explained that they are focussed on sports included in the next Olympic cycle.

NATIONAL COACHES COMMITTEE

The Chair (Marco Mazzanti) and Deputy Chair (Mark Golding) are currently reviewing and will be making recommendations to the board as to the future structure and direction of the National Coaches programme.

NATIONAL REFEREE COMMISION

The National Referee Commission, under the leadership of Dion Panossion, has ensured that Australian referees have been kept up to date with developments around the world. The Commission has conducted seminars and assisted State Commissions as required.

The Deputy Chair of the National Referee Commission, Nghia Tran has been appointed to the WKF Referee Commission and this continues a long involvement of having an Australian on the WKF Referee Commission. Congratulations to Nghia as all our referees benefit from his involvement.

AUSTRALIAN SPORTS COMMISSION

Karate Australia works very closely with Sport Australia in several key areas.

- Participation and membership bi-annual reviews
- Corporate Governance compliance
- Sport Integrity
- CFO monthly meeting
- Grants and acquittals
- Strategic Planning

Whilst the demands on the AKF from various departments within Sport Australia often feel overwhelming, the support that it provides both financially and with advice is invaluable.

Corporate Governance and Legal assisted with the finalising of several key points in the constitution. We continue to work with Corporate Governance to improve our structures and processes.

In February 2023, the Corporate Governance team at the Sports Commission assisted with hosting a Strategic Planning session. This session will provide the framework for ongoing development of the Karate Australia strategic plan.

Financial services, meetings and advice is always available when required, thank you to all concerned.

NATIONAL SPORTS COLLECTIVE

The National Sports Collective is a working group made up of the CEOs of a number of sports including badminton, special Olympics, archery, table tennis, deaf sports, diving, bowls, waterpolo, blind sports, squash, tenpin, baseball, disabled winter sport, artistic swimming, shooting, taekwondo, boxing, judo, skate, lacrosse and karate.

The group was formed in an attempt to share knowledge, experiences, contacts, documents and even staff. We meet once a month but communication between group members is almost daily, assisting each other wherever possible.

The group has been one of the most valuable resources to me in my role as CEO, and I would like to thank everyone involved.

The group is currently in the process of employing an individual to work with and for sports in liaising with various interest groups.

WORLD COMBAT GAMES

The qualification process for the World Combat Games 2023 in Riyadh, Saudi Arabia has just been released. The Games will be held a few days before the 2023 WKF World Senior Championship. Gold medallists from the U21 Oceania Championship to be held in Christchurch New Zealand (30 June 2023) will qualify for this event.

Good luck to those vying for qualification.

COMMONWEALTH KARATE CHAMPIONSHIPS

The Commonwealth Karate Championship was held in Birmingham, England in September 2022. Karate Australia had a strong team of 53 entries (28 athletes).

Australia finished 3rd behind hosts England and Scotland with the following athletes winning gold: Mia Heran (Junior Female -48kg) Rory Attridge (U21 Male -75kg) Mitchell Durham (Senior Male -75kg)

Australia won through to the final in both the Senior Male and Senior Female team Kumite events winning gold for the female division and silver in the male division.

OCEANIA KARATE CHAMPIONSHIPS 2022

After two postponements the Oceania Karate Championships and The Oceania Cup was held in New Caledonia 4-6 June 2022. We had the largest delegation at these championships and continue the long tradition of Oceania success.

Australia won on the medal count taking home 27 gold medals.

OCEANIA KARATE CHAMPIONSHIPS 2023

Due to the pandemic the cycle whereby the full Oceania Championships (Cadet / Junior / U21 and Senior) were held in a Senior World Championship year has gone out of synchronisation.

In 2023 therefore there will be a championship for Cadet and Junior to be held at the Australian Open and U21 and Seniors at the New Zealand Open. This will bring the calendar back into sync with the Senior World Championship in 2025.

Good luck to those athletes selected to represent Australia at these Championships.

2022 AUS OPEN KARATE CHAMPIONSHIP

The 2022 Australian Open was successfully held in April 2022. The entries were down significantly compared to pre-pandemic numbers with 602 entries (331 athletes). However, this did not damper the level of competition and excitement.

Well done to the NSW Karate Federation for hosting a fantastic event

2023 AUS OPEN KARATE CHAMPIONSHIP

Looking forward we have the 2023 Australian Open, where registration numbers clearly show that the pandemic is truly behind us.

This is set to be one of the biggest Australian Open's ever with 900 entries, 94 clubs and 513 competitors from 8 countries. It really feels good to be back!

AKF NATIONAL CHAMPIONSHIPS

The AKF had not been able to conduct a national championship since 2019. In 2022, recognising the uncertainty of border restrictions and cost the West Australian Karate Federation graciously offered the eastern states the opportunity to host. The Queensland Karate Association hosted the championship and for the 1st time in a regional centre, Rockhampton, Central Queensland.

The participation from the States was terrific and well done to all the competitors.

In 2023 the Championships will be hosted by West Australia, and in 2024 Victoria will host the 50th anniversary event.

PACIFIC GAMES

In November 2023 the Pacific Games will be held in the Solomon Islands. This is a multisport event which is well attended by the island nations. Australia and New Zealand do not compete in Pacific Games Karate competition but are intimately involved in the provision of services and officials for the games.

This is an important activity for the Federation and its role in the region.

BRANDING

In last year's report I referred to the fact that the Federation would use the name Karate Australia where it relates to member services. This is in keeping with the trend in most Australian sports. In the 2nd half of 2022 the Company sought concepts from members and the greater community to design a logo incorporating the name Karate Australia and reflecting the sport and brand.

A large number of entries were received, and the board finally selected the new logo that is in use on the website, badges and other branding opportunities.

The logo has been designed so that different colours may be used to represent different elements of Karate Australia.



Corporate Use - This logo is used when referring to the Company and activities outside the sporting realm.



Sporting Use - All sports events, teams, news that relate to sporting events use the green and gold.

The website domain is karateaustralia.org.au

SPORTING SCHOOLS

Karate Australia is excited to confirm that we are in the final stages of gaining approval as a Sporting Schools provider. This will benefit our member organisations and help develop karate at a grassroots level. Sporting Schools is an Australian Government initiative designed to help schools increase children's participation in sport and connect them with community sport opportunities. More information about the program can be found on the <u>Sporting Schools website</u>

Karate Australia is seeking information from our member clubs and their interest and availability to take advantage of this program. A survey will soon be sent to member clubs

as the final criteria of approval. Karate Australia urge all member clubs, dojos and instructors to complete the survey.

Thank you to Michael Panossian for all of his work with Sporting Schools and the Australian Sports Commission over the past 18 months to secure this opportunity for our members.

STRATEGIC PLAN

In February 2022 the Karate Australia was assisted by Australian Sports Commission in facilitating a meeting of the Board, all Recognised State Associations, Portfolio Chairs and the National Office. This meeting worked through several areas to identify a strategy for the development of a National Participation Strategy Plan. This plan will be worked on during the year and presented to members for input later in the year.

PARTICIPATION PLAN

Karate Australia needs to create a plan to reflect our changing environment and priorities. This plan will need to take account of the Strategic Plan and Federal Government priorities over the next 3 years. Our priorities will include building on and evolving our current programs to increase participation, supporting our members through product development, resourcing and developing our digital and online presence to promote karate nationally.

POLICIES

Karate Australia is once again currently reviewing and updating a number of policies in line with the National Integrity Framework. During 2022, the board adopted the National Integrity Framework however these have now been reviewed by Sport Integrity for the sector and a new set of policies is being developed.

Once these are finalised these will be rolled out to states and clubs for adjustment and adoption.

- Child Safeguarding
- Competition Manipulation & Sports Wagering
- Complaints And Discipline
- Improper Use Of Drugs & Medicine
- Member Protection

Review of policies is an ongoing process, and all policies will be reviewed and updated on a regular basis. This will include The Athlete Selection Policy and the Athlete Appeal Policy.

NATIONAL TEAMS AND SELECTION

The current Selection Policy remains in place. Any additional protocols that need to be implemented will be done when the Selection Policy is reviewed.

The WKF trend is very clearly toward a ranking qualification for events and the Karate Australia Selection Policy will need to take this trend into account.

Selected events in 2023 include the Cadet / Junior Oceania Championship, the Senior / U21 Oceania Championship and the Senior World Championship.

KARATE AUSTRALIA ACCREDITED CLUB

Immediately after the 2023 AGM, Karate Australia will launch the Find a Club page on the Karate Australia website. The public can search for a Karate Australia Accredited club by post code or suburb.

At the same time Karate Australia is launching the Karate Australia Accredited Club logo use guidelines. These guidelines will be sent to members soon.



CALENDAR

Both the International and Domestic sports calendar has become busier each year. Karate Australia will work with States to create a national calendar for 2024 which maximises the opportunity for competitors to compete on a regular basis.

REFEREE STANDARDS

The National Referee Commission works closely with State Referee Commissions to ensure consistent standards and processes in all States and Territories. The use of online education has assisted in the process and will expand in the coming years.

There is a concerted effort to encourage more referees to get involved.

The WKF has implemented a Referee Standardisation programme which will be filtered down to National and State programmes.

TOURNAMENT OFFICIALS

The challenges experienced by States in finding tournament officials is anecdotally better than last year, however this remains a perennial problem. Karate Australia is working with other sports to develop strategies to encourage participation by volunteers. This remains a priority for next year and the National Office will work with the States to develop strategies that have proven successful.

SOCIAL MEDIA

Members will have noticed a significant increase in Social Media posts over the last 6 weeks. This volume will continue, and content is being created on a regular basis.

Members are encouraged to share content and tag karateaustralia in posts.

Thank you to our sponsor OmniOnline for their support and special mention to Miranda Engberg for her help and encouragement.

EDUCATION

There are a number of education opportunities available to our members. Karate Australia is working with Sport Australia to create a portal where Karate Australia can provide a range of educational opportunities.

The cost of accreditation has been significantly reduced and it is expected that the number of members taking advantage of educational opportunities and pathways will increase.

Education has initially been rolled out in the Karate Instructor Accreditation module and will soon follow with tournament officials. Karate Australia is currently looking at a number of business modules that would be of benefit to our clubs and educational pathways document is being planned to provide guidance to members.

OTHER SPORTS

Karate Australia is very fortunate to have the opportunity to discuss issues on a regular basis with other sports in various forums, including Sport Australia meetings, the National Sports Collective, and one on one sessions with other sport CEOs.

Regular discussions with other non-commercial sports have highlighted common issues and concerns and we will work even closer together to ensure that we achieve a common outcome in negotiations with government agencies.

The Australian Sport Commission has created a group that meet 4 times a year to discuss participation issues and ideas. Karate Australia is an active member of this group.

GRANTS AND FUNDING

In the past Karate Australia was principally funded by the Sport Australia Participation Grant. This grant is under review by the Commission and will end. Going forward with the membership base that has been achieved over the last year means that the company is not reliant on the grant in the future. It also means that grants that become available to encourage and support participation growth, can be matched by the company as required.

The Participation Grant for 2023 has been secured.

CORPORATE GOVERNANCE REVIEW

The Company continues to work with the Corporate Governance team at the Sports Commission, who have been exceptionally supportive, including in person meeting in our office.

The company is currently undertaking a self-evaluation of Corporate Governance standards, and this will be completed in the next month.

Areas to develop the governance of the company are:

- Board evaluation process
- Develop a documented process for identifying and appointing directors including the role of a nomination committee in the process.
- Identify strategic and/or collaborative activities requiring stakeholder engagement to form engagement strategy.
- A Code of Conduct and execution by each director.

STATE GOVERNANCE REVIEW

As part of the Corporate Review, Strategic Plan and Partipation Plan reviews, Karate Australia is looking at a State Governance Reform project to support governance improvement for karate in Australia. Central to the improvement will be the new Australia Whole of Sport Strategy and the opportunity it presents to support a dialogue with key stakeholders in the state and territory network. The project will deliver a robust, collaborative and high engagement process with the following two key outcomes:

- 1. Co-creation of a national strategy template for the Australian Karate Federation, populated and tailored for each local state/territory environment.
- 2. Development of a Roadmap (a formal plan with an agreed and appropriate timeline) to move towards streamlined governance and a shared services model

This process is not currently scheduled but will form a key initiative in taking the Karate Australia into the future in a shared service model.

KARATE 1

A few years ago, the WKF created the Karate 1 programme, which includes Premier League, Serie A and Youth League events.

Several Australian athletes are active participants in this programme, where they are able to accumulate WKF ranking points. The nature of the programme has created complexity in the ability of Karate Australia to support athletes at all these events, principally due to their world ranking. Some athletes can only go to Premier League events and other only Serie A events. Karate Australia has endeavoured to provide coaches at a number of these events and will continue to do so.

Thank you to Aashiqah Dickinson, who has taken on the role of registering Australian participants with very tight deadlines.

BOARD EVALUATION & EDUCATION

In recognition of the important leadership role Directors hold within the Australian sport landscape, Sport Australia have partnered with the State Territory Agencies for Sport and Recreation to develop an online Director Education Course - The Start Line. This course provides the foundational knowledge to enable new and existing Directors to understand their duties and responsibilities and to make an effective contribution to their organisation's Board. The members of the Board are expected to complete this online course within the first 2 months of taking up their positions.

Consistent with the Sport Governance Standard 9.1 "The board should regularly evaluate its performance and performance of individual directors. The board should agree and implement a plan to take forward any actions resulting from the evaluations". To this end the board members will conduct a self-evaluation and create a set of objectives that will form part of the board structures and processes for the future.

FINANCIAL REPORT

The Audited Financial Statements for the 18 months ended 31 December 2022 have been provided.

Last year's Annual Report included provisional Financial Statements for the 6 months to December 2021, whilst the company was in the process of changing its financial year and reporting period to a 31 December year end, to better align with its activities which are planned and budgeted for on a calendar year basis.

The Profit and Loss statement therefore needs to be read as an 18 month (current reporting period) compared to a 12 month (previous reporting period).

The company made a small profit of \$10,723 for the calendar year 2022, with an adjustment against the previous 6 months of \$5,358 for the previous financial period.

There was a significant increase in the cost of insurance as the Company now insures its members and the cost of 2 world championships in the reporting period.

The AKF will prioritise building up its cash balances / reserves in the coming years in order to better position itself for contingencies. The board will closely monitor expenses and will curtail these where necessary, with expenses to be reviewed on a regular basis to ensure that the organisation remains in a profitable position in future years.

Hani Zahra presented the Chair report to the Membership. He notes that 2002 marks 50 years since the formation of FAKO in 1972. He acknowledges Sal Ebanez as one of the founding members of the FAKO. In closing, he recognises two of the former board members who are not continuing. Michael Jones, who joined the board in 2017 and initially worked as the Treasurer and then as a director, and Donald James, who has been involved for 14 years as Vice President then as a director. He acknowledges their support and service to the Federation.

Chief Executive Officer (CEO) - Ian Basckin

Ian Basckin presented the report of the CEO including Activities and the Financial Report. The report was a good opportunity to reflect on the work achieved in the AKF office and notes Natasha Ramrakha for her assistance and service.

Auditor - Edward Chahoud

Ian Basckin presented the auditor's reports for 30 June 2020, 30 June 2021 and 31 December 2021. The financials needed to be completed in this way in order to move onto the 31 December year end model.

6. Questions from Members

Craig Catania commented that the consultation period around the formation of the new membership model and finalising the new structure was not done to the satisfaction of some members. Craig mentioned how the initial communication and consultation suggested the formation of a working group that will then put forward ideas to the board. Craig asks how the AKF came to the model that was created. Ian Basckin discussed that the initial consultation with the volunteered members put forward a vast array of suggestions and concerns with the previous model of the AKF. There was very little consistency. This led the AKF to seek advice from an external consultant from Sport Australia. The consultant advised the AKF to focus more on creating a product and service that met as many of the concerns of the members as possible as well as the demands from Sport Australia, while also offering the services the AKF had provided in the past. The issue was that the initial pricing for a model that met these standards was far too high. After revision by the board and further consultation, the cost of \$25 was supported by the Board. AKF initially communicated a rebate offer to members with the price being \$50 with a rebate amount of \$25 to the Head of Style. The Board accepted feedback from Heads of Style around not wanting the rebate and simply passing on the \$25 registration. As such, the confirmed registration fee would be \$25 per individual member. Hani Zahra noted that there are many different club structures within the AKF. He reiterated that the previous AKF model was historical and not consistent with other sports. The AKF was guided by Sport Australia. Edji Zenel, Craig Catania, and Rene Roggeveen expressed concern around communication and discussed their issues with the membership model.

2 Summary Of Significant Accounting Policies

Basis of Accounting

In the opinion of the Management Committee, the company is not a reporting entity because there are no users dependent on general purpose financial reports.

Revenue recognition

Employee Entitlements

Provision is made for the Company's liability for employee entitlements arising from services rendered by employees to balance date. Employee entitlements are measured at their nominal amount. The amount charged to the income statement in respect of superannuation represents the contributions made by the Company to superannuation funds during the financial year.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the Australian Taxation Office (ATO), in this case it is recognised as part of the cost of acquisition of the asset or as part of the expenses.

Receivables and payables are stated inclusive of the amount of GST receivable or payable.
